Information We Collect

Information You Provide

- **Contact and Registration Data:** Name, email address, phone number, mailing address, and any details you provide when registering for retreats, workshops, newsletters, or contacting us.
- **Payment Information:** When you make a purchase (via Kajabi or Stripe), we collect billing information. Credit card details are processed securely by our payment providers and are not stored on our servers.
- **Retreat and Service Data:** Dietary preferences, emergency contacts, travel information, health considerations (where relevant and voluntarily shared), and any other information you submit in forms or communications.

Information Collected Automatically

- **Usage and Device Data:** IP address, browser type and version, operating system, device type, pages visited, time spent on pages, clickstream data, and referral sources.
- **Cookies and Tracking Technologies:** We use cookies, web beacons, and similar technologies to remember your preferences, analyze site traffic, and improve your experience.
- **Analytics:** We use tools like Google Analytics to understand how visitors use our site.

We do not knowingly collect personal information from children under 18.

How We Use Your Information

We use the collected information to:

- Process transactions and manage registrations for retreats and programs.
- Communicate with you about your purchases, retreats, and updates.
- Personalize your experience and improve our website and services.
- Send marketing emails (you can unsubscribe at any time).
- Analyze site usage and improve functionality.
- Comply with legal obligations and protect our rights.

How We Share Your Information

We may share your information with:

- **Service Providers:** Kajabi (platform and payments), Stripe (payment processing), email marketing tools, analytics providers, retreat venue partners, and other contractors who help us operate our business. These providers are contractually obligated to protect your data.
- **Legal Requirements:** When required by law, court order, or government request.
- **Business Transfers:** In the event of a merger, acquisition, or sale of assets.

We do **not** sell your personal information.
